



**GRANTLEY ADAMS INTERNATIONAL AIRPORT INC.**  
**TENDER NOTICE FOR THE SUPPLY**  
**OF**  
**SCREENING SERVICES FOR CHECKED BAGGAGE**  
**AT THE GRANTLEY ADAMS INTERNATIONAL AIRPORT**

1. The Grantley Adams International Airport Inc. (“GAIA Inc.”) invites tenders for the supply of screening services for checked luggage at the Grantley Adams International Airport in accordance with the international standards and recommended practices and procedures of the International Civil Aviation Organisation (“ICAO”), the Convention on International Civil Aviation (“Chicago Convention”) and all local and regional civil aviation security laws, regulations and agreements to which Barbados is a signatory (“screening services”).
2. The provision of screening services shall be provided seven (7) days a week for a period of three years in accordance with the schedules of departing flights and whenever the screening services are required.

4. Tenders must be enclosed in a sealed envelope, bearing no identity of the Tenderer, and clearly marked “**TENDER FOR SUPPLY OF SCREENING SERVICES FOR CHECKED BAGGAGE AT THE GRANTLEY ADAMS INTERNATIONAL AIRPORT**” on the top left-hand corner.

A mandatory Site Meeting will be conducted at 2:00 p.m., **on Friday, March 10, 2023**

6. The Labour Clauses (Public Contracts) Act CAP 349 shall, in so far as is applicable to the subject of the tenders, apply to any contract made in respect of the tender.
7. Tenderers must submit copies of valid Certificates from the Director, National Insurance and the Commissioner of Barbados Revenue Authority confirming that there are no outstanding payments due to the institutions by the tenderers. Any tender received without these certificates shall be deemed void and will not be considered.
8. All corporate tenderers must include with the tender a copy of the company's Certificate of Incorporation. Failure to do this will render the tender void and it will not be considered.
9. No tender will be considered unless it complies with the conditions set out in the Notice and the Tender Documents.
